Goal 2: Availability of RTI; Instructional Coach to facilitate the development of teachers with focus on improving student achievement; Curriculum & Instruction Specialist to train teachers on the use of curriculum course content; School Counselors and teachers to monitor student progress and needs; Identify, monitor and support students who are struggling with attendance; Frequent contact with students and parents; Recruit and retain highly qualified multiple and single subject teachers and classified staff.

Goal 3: Effective and meaning transparent communication; Notices, reports and records translated as needed; Engage students and parents in the participation of school planning through EPAC; Build relationships by ensuring all parents, students and teachers feel our school is providing a safe, positive, inclusive and welcoming environment; Build partnerships for student outcomes through notification of surveys; EPAC, Board Meetings via email, website, social media.
